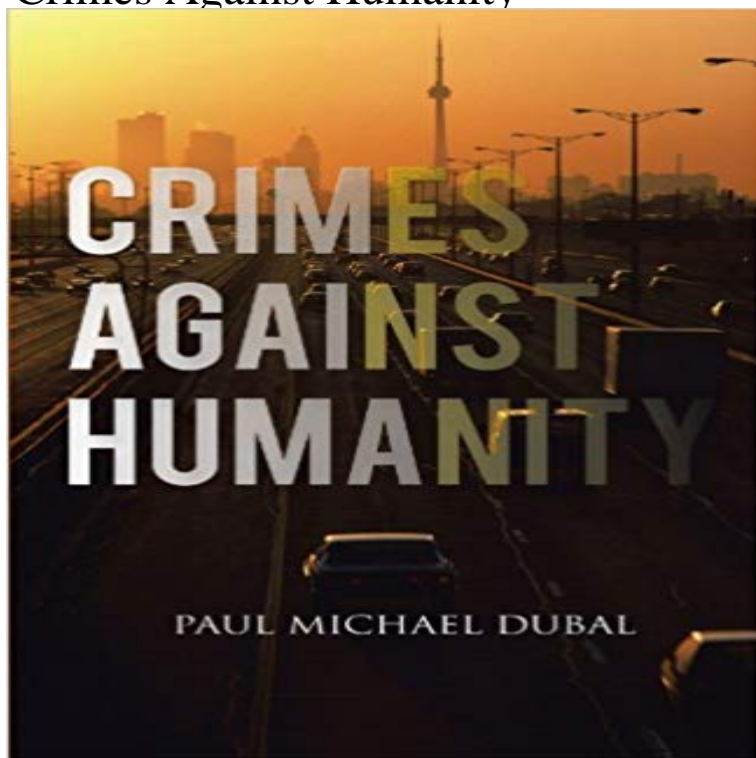


## Crimes Against Humanity
