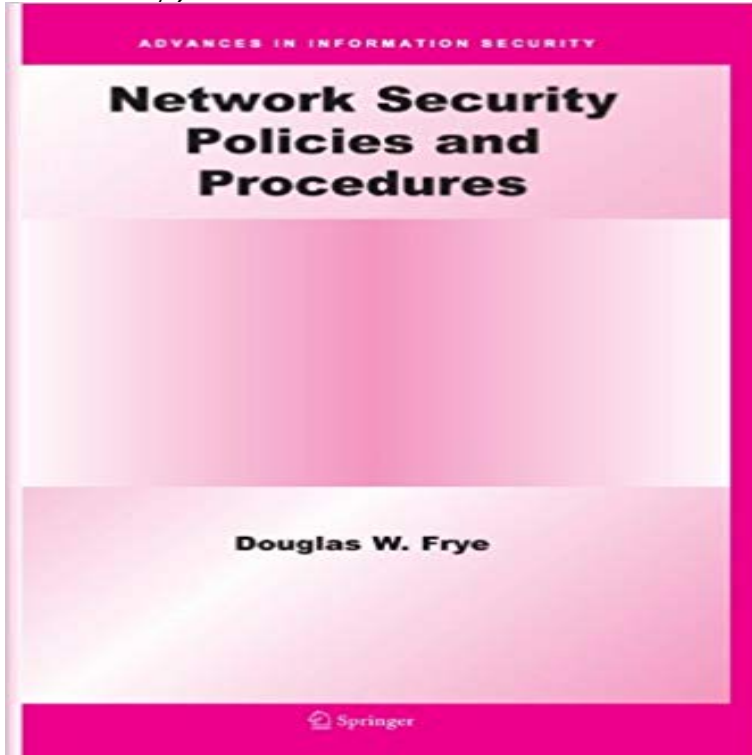


Network Security Policies and Procedures (Advances in Information Security)
