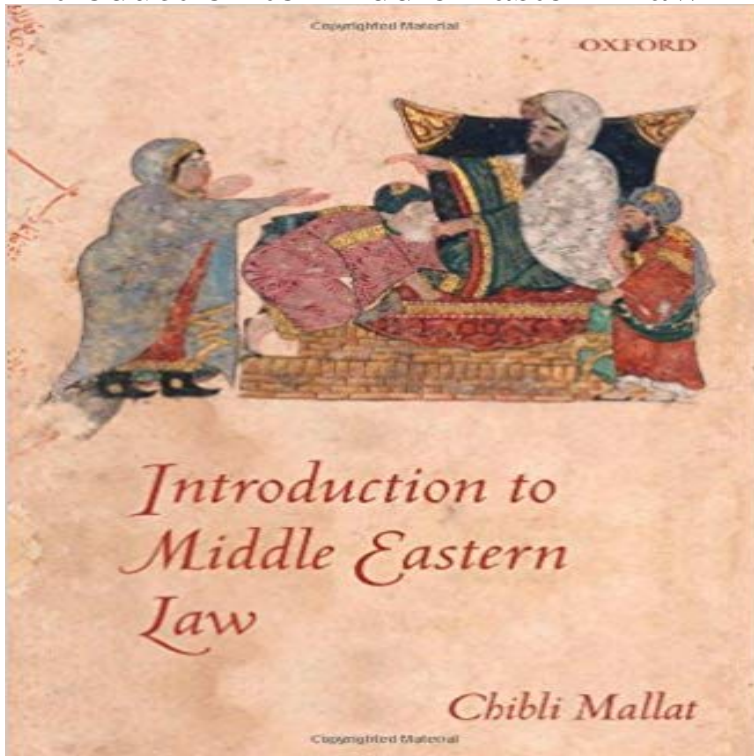


# Introduction to Middle Eastern Law
