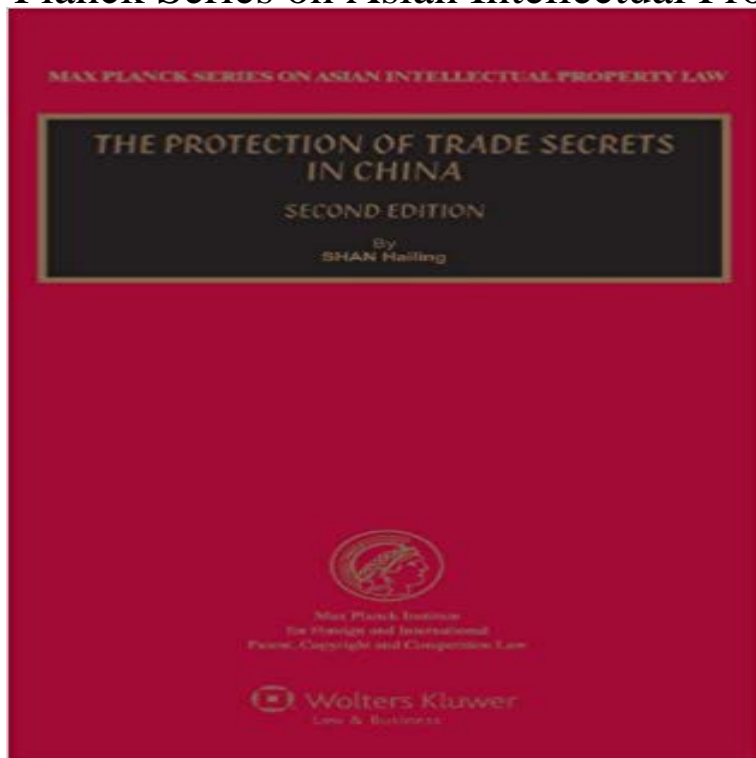


The Protection of Trade Secrets in China, Second Revised Edition (Max Planck Series on Asian Intellectual Property Law)
