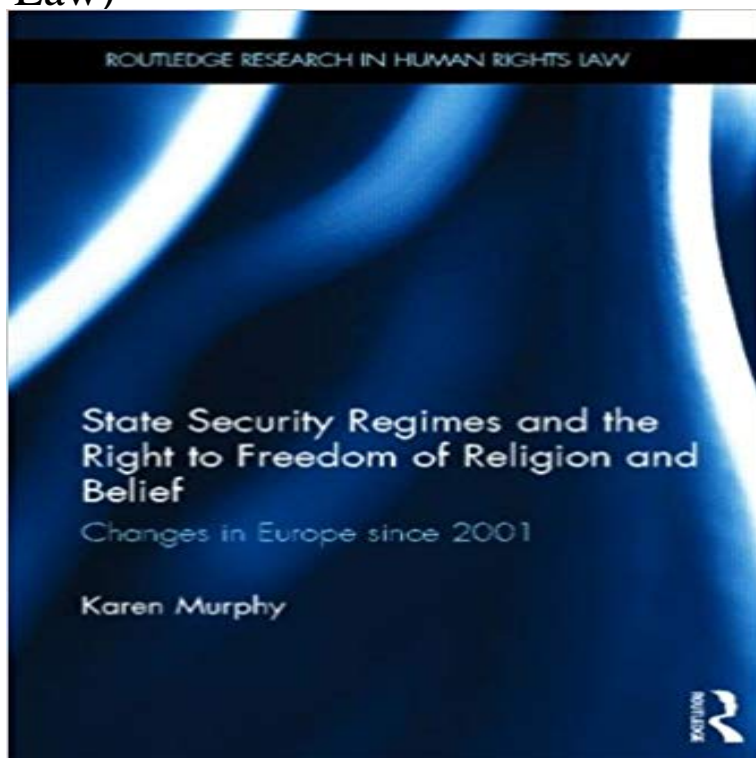


# State Security Regimes and the Right to Freedom of Religion and Belief: Changes in Europe Since 2001 (Routledge Research in Human Rights Law)
